



GoFish Challenge – Murray Cod Championship

1. This competition is administered by GoFish Nagambie Pty Ltd (4/3 Rocklea Drive, Port Melbourne VIC 3207, ABN 4260 6621 989) and Trellly's Pty Ltd (209 Corio St Shepparton VIC 3630, ABN 72 612 795 070) are the prize supplier and Sponsor ("Trellly's")
2. This competition (the "Competition") is a game of chance whereby entrants are asked to upload a 'trophy shot' (photograph) with a Murray Cod via an online submission form
3. All Entrants ("**Entrants**") who participate in this Competition are deemed to accept these terms and conditions of entry. Entries that do not comply with these terms and conditions will be deemed invalid and GoFish Nagambie and Trellly's take no responsibility for such entries.
4. All times given in these terms and conditions are references to Australia Eastern Standard Time and all references to currency are referring to Australian Dollars.
5. The Competition Entry Period opens at 9:00am on Monday 18th May 2020 and closes at 11:59pm on Sunday 31st May 2020 (the "**Competition Period**").
6. To be eligible for entry into this Competition, an Entrant must:
 - a. Upload their photo entry and the **Competition Entry Form** on the GoFish Nagambie website
 - b. Fill out the form outlined in point 2
 - c. Enter during the competition entry period outlined in point 5
7. By entering the Competition, Entrants consent to being contacted by GoFish Nagambie or their representative
8. The Prizes are all provided by Trellly's. There is one (1) major prize to be won, a Shimano Zodius Baitcast Rod valued at \$300. There are four (4) minor prizes to be won, a Trout Pack assorted lures and accessories valued at \$180, a Ugly Stick Esky valued at \$89, 8 Pack Old Mate Lures in Tackle Box valued at \$179 and a Shimano Exage 2500 reel valued at \$129.
